**Re:** Adjustment to Fiscal Year 2013 Program Rates

The Maryland Medical Assistance Program will increase the reimbursement for services rendered to Medicaid clients under COMAR 10.09.53 effective July 1, 2012. Specifically, rates will increase by 1 percent based on the Medical Assistance Program's budget for Fiscal Year 2013.

Attached is a chart of the revised fee schedule for Fiscal Year 2013. Providers may bill the new rates for services provided on or after July 1, 2012. Please note that, the rate for Certified Nursing Assistants/Home Health Aide services will not be increased for Fiscal Year 2013. Providers should continue to utilize the rates noted in the fee schedule for FY 2012 for Certified Nursing Assistants/Home Health Aide services.
